About Us

The Planned Giving Council of Greater Philadelphia is our region's leading professional association for individuals involved in charitable gift planning. Our members represent a broad spectrum of educational institutions, as well as charitable organizations that engage in health and human services, arts, culture, and the environment.

Our membership also includes representatives from financial institutions and organizations that provide services in finance and estate planning.

As an affiliate of the National Association of Charitable Gift Planners, our mission is to increase the quality and quantity of charitable planned gifts by serving as the premier professional resource for the gift planning community.

Prospective Audience

The PGCGP has almost two hundred members from the Philadelphia, New Jersey, and Delaware metro region, including members from many of the region's largest not-for-profit organizations and universities. Our programs also attract those new to planned to give, generalists whose duties include planned giving, major gift officers and allied professionals such as philanthropic advisors, estate attorneys, certified public accountants, and financial advisors.

Sponsorship Avenues

In 2024, we continue to update our sponsorship opportunities to better reflect our organizational needs. We plan to host our premier educational program – the Planned Giving Day Conference – in-person at the Inn at Villanova on Wednesday, October 16, 2024.

Educational Programs: PGCGP educational programs are typically scheduled between 11:00am to 2:00pm and include an expert speaker on topics related to planned giving and philanthropy. In 2024, PGCGP will be offering three in-person educational programs in March, June, and September.

Networking Event: During the summer, join the Planned Giving Council's past and current members in a first ever networking event (limited to 50 attendees). The attendees will go through an interactive learning session on values, focus areas, and the latest research on how to further your client or donor's philanthropic work. In this workshop and mini-networking session, uses research from Stanford University's Center on Philanthropy and Civil Society to explore a foundational process fundraiser's can discuss with their clients/donors to help them be most effective in pursuing philanthropic goals.

Planned Giving Day Conference: We will be hosting our annual premier educational conference in-person event on Wednesday, October 16, 2024, at the Inn at Villanova, with interactive and engaging break-out education sessions – and some not offered anywhere else.

Planned Giving Course: The Planned Giving Course provides a foundation for fundraising professionals just entering the field of Planned Giving as well as technical knowledge for financial advisors and attorneys regarding how to incorporate charitable giving in an overarching financial and estate plan for their clients. Coming out of the pandemic, the course has been revisited to ensure that the sessions, timing, and platform support the needs and expectations of potential participants and reflects the changes in the nonprofit sector while looking to widen the audience of attendees. For 2024, the Planned Giving Course will be offered through a hybrid model incorporating formal learning (webinars and workshops), access to mentors, and peer-to-peer interactions. The PG Course will be held in the Spring of 2024. The in-person session will be held at the American College of Financial Services offices in King of Prussia, PA. All sponsors will be recognized in the Planned Giving Course materials and during introductions.

Quarterly Newsletter and Communicating with our Members: We communicate with our members and colleagues in many ways including the PGCGP Newsletter as well as via Eblast and LinkedIn postings. Regular Eblasts are sent to our membership database, as well as hundreds of others who requested to be included in our distribution list. LinkedIn postings are seen by those who are linked with PGCGP and who follow us on the platform.

Website: Our website is visited by hundreds weekly. Members access the site for information about and registration for upcoming programs, to download handouts from previous programs, and sponsor-driven Whitepapers. Members also frequently access the job opportunities and newsletter page.


